WHEREAS, according to statute, a County Board of Commissioners shall meet on the Tuesday following the second Monday in April to equalize the assessment rolls; and

WHEREAS, there is a regularly scheduled meeting of the Washtenaw County Board of Commissioners on April 15, 1998

WHEREAS, the Board of Commissioners wishes to cancel the August 5, 1998 Ways & Means Committee , August 5, 1998 Board of Commissioners session, and August 6, 1998 Board Working Session; and

WHEREAS, the Board of Commissioners wishes to reschedule these meetings for August 12, 1998 for Ways & Means Committee, August 12, 1998 for the Board of Commissioners session and August 13, 1998 for the Board Working Session

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby adopts the amended 1998 August schedule for the 1998 Annual Calendar for the Board of Commissioners, as attached hereto and made a part hereof.
