

A RESOLUTION RATIFYING THE SIGNATURE OF THE CHAIR OF THE BOARD ON THE application to the Michigan Jobs Commission (MJC) for the FY 1999 Michigan Works! System Implementation Grant APPLICATION for the period January 1, 1999 through December 31, 1999 in the amount of \$134,536; AUTHORIZING THE ADMINISTRATOR TO SIGN THE NOTICE OF GRANT AWARD; AMENDING THE BUDGET AND AUTHORIZING THE ADMINISTRATOR TO SIGN DELEGATE CONTRACTS

WHEREAS, the Employment Training/Community Services Group is the administrator and operator of Employment and Training programs in Washtenaw County; and

WHEREAS, the Employment Training/Community Services Group is funded by the Job Training and Partnership Act, the Michigan Department of Labor and the Michigan Jobs Commission to provide employment training and placement services; and

WHEREAS, the Washtenaw County Workforce Development Board and the Board of Commissioners oversee, recommend and approve employment and training programs throughout Washtenaw County; and

WHEREAS, the MJC has recently executed an agreement with the United States Department Of Labor (USDOL) to continue the funding for Michigan Works! System for a second year; and

WHEREAS, the Michigan Works! system focuses on providing information and resources to enable our customers, job seekers and employers, to successfully compete in today's economy and achieve economic security; and

WHEREAS, the goal of the Michigan Works! system is that every entry point leads to services relevant to our customers; and

WHEREAS, collocation of service providers and the integration of services to the fullest extent possible are the priorities of this system; and

WHEREAS, the basis of the system has emerged as a comprehensive strategy designed to break down barriers and promote the establishment of a service delivery system which is responsive to the needs of our customers.; and

WHEREAS, this matter has been reviewed by the Washtenaw County Workforce Development Board, the County Administrator's Office, Corporation Counsel, Finance, Human Resources, and the Ways and Means Committee

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby ratifies the signature of the Chair of the Board on the FY 1999 Michigan Works! System Implementation Grant application for the period January 1, 1999 through December 31, 1999 in the amount of \$134,536 for the Employment Training/Community Services Group, as on file with the County Clerk.

BE IT FURTHER RESOLVED that the Board of Commissioners takes the following actions contingent upon receipt of the grant award in conformity with the application:

1. Authorizing the Administrator to sign the Notice of Grant Award
2. Amending the budget, as attached hereto and made a part hereof
3. Authorizing the Administrator to sign the delegate contracts upon review of Corporation Counsel to be filed with the County Clerk
