

A RESOLUTION RATIFYING THE SIGNATURE OF THE COUNTY ADMINISTRATOR ON THE PROGRAM YEAR (PY) 1998 TITLE IIC PLAN MODIFICATION TO THE MICHIGAN JOBS COMMISSION (MJC) FOR THE PERIOD OF JULY 1, 1998 TO JUNE 30, 1999 IN THE AMOUNT OF \$147,744 FOR THE EMPLOYMENT TRAINING/COMMUNITY SERVICES GROUP; AUTHORIZING THE ADMINISTRATOR TO SIGN THE NOTICE OF GRANT AWARD; AMENDING THE BUDGET AND AUTHORIZING THE ADMINISTRATOR TO SIGN DELEGATE CONTRACTS

WASHTENAW COUNTY BOARD OF COMMISSIONERS

WHEREAS, the ETCS Group requests the approval of the 1998 JTPA Title IIC Job Training Plan Modification; and

WHEREAS, the ETCS Group is the administrator and operator of Employment/Training programs in Washtenaw County. The ETCS Group is funded by the Job Training Partnership Act, the Department of Labor, and the MJC to provide employment training and placement services; and

WHEREAS, the Employment Training and Community Services Group has received notification of Carry-In funds in the amount of \$89,502 from the Title IIB Summer Youth Program; and

WHEREAS, the Title IIB program operates only during the summer when its youth participants are out of school; and

WHEREAS, the Title IIC program operates all year providing services to eligible youth; and

WHEREAS, the funds will be transferred to the Title IIC program to provide enhanced service to eligible youth; and

WHEREAS, the ETCS Group has revised the PY 1998 Title IIC Job Training Plan to serve 60 eligible youth participants with a total allocation of \$147,744 for the period of July 1, 1998 through June 30, 1999; and

WHEREAS, the primary services available to participants will include: classroom training, competency-based training, on-the-job training, in-school youth program, work experience, support services, and special outreach for non-traditional work opportunities, or combinations of these; and

WHEREAS, the funds may also be used to provide such services, among others, as: basic skills training, counseling, case management services, school-to-work activities, work-based learning instruction, skill upgrading and retraining, entrepreneurial training; and

WHEREAS, this matter has been reviewed by the Washtenaw County Workforce Development Board, Corporation Counsel, the Finance Department, Human Resources, the County Administrator's Office, and the Ways and Means Committee

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby ratifies the signature of the Chair of the Board on the PY 1998 Title IIC Job Training Plan Modification to the Michigan Jobs Commission for the period July 1, 1998 through June 30, 1999 in the amount of \$147,744, as on file with the County Clerk.

BE IT FURTHER RESOLVED that the Board of Commissioners takes the following actions contingent upon receipt of the grant award in conformity with the application:

1. Authorizing the County Administrator to sign the Notice of Grant Award
2. Amending the budget as attached hereto and made a part hereof
3. Authorizing the County Administrator to sign the delegate contracts upon review
by Corporation Counsel, to be filed with the County Clerk
