

A RESOLUTION RATIFYING THE COUNTY ADMINISTRATOR'S SIGNATURE ON AN APPLICATION WITH THE MICHIGAN DEPARTMENT OF COMMUNITY HEALTH, OFFICE OF DRUG CONTROL POLICY FOR D.A.R.E. FUNDING IN THE AMOUNT OF \$21,579 THROUGH THE BYRNE MEMORIAL FORMULA GRANT PROGRAM FOR THE PERIOD OF OCTOBER 1, 1999 THROUGH September 30, 2000

WASHTENAW COUNTY BOARD OF COMMISSIONERS

WHEREAS, the Washtenaw County Sheriff's Department has long been a proponent of educating the children in Washtenaw County in drug resistance education; and

WHEREAS, the Sheriff's Department wishes to enhance the D.A.R.E. program in middle and high schools; and

WHEREAS, the Washtenaw County Sheriff's Department is requesting authorization to submit an application for D.A.R.E. funding for the third consecutive year; and

WHEREAS, this funding in the amount of \$21,579 will be used to enhance D.A.R.E. classes in the middle and high school venue, which will provide for a continuum of core classes which were taught in the preceding level; and

WHEREAS, the grant if awarded will cover 75% or \$16,184 of the program costs which will absorb 40% of the total annual salary for the deputy providing D.A.R.E. instruction; and

WHEREAS, the 25% or \$5,395 match requirement will be a cash match and absorbed within the Sheriff's Department's current budget; and

WHEREAS, this matter has been reviewed by the County Administrator's Office, the Finance Department, Human Resources, Corporation Counsel and the Ways and Mean Committee.

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners ratifies the County Administrator's signature on an application with the Michigan Department of Community Health, Office of Drug Control Policy, for the D.A.R.E. funding in the amount of \$21,579, through the Byrne Memorial Formula Grant Program for the period of October 1, 1999 through September 30, 2000

FURTHER RESOLVED that the Board of Commissioners approves the following actions contingent upon the receipt and conformity of the grant award.

1. Authorizes the Chair of the Board and/or County Administrator to sign the Notice of Grant Award.
2. Amend the budget as necessary. (See attached)
3. Authorizes the County Administrator to sign delegate contract(s).
