

A RESOLUTION AUTHORIZING THE SIGNATURE OF THE ADMINISTRATOR ON THE APPLICATION TO THE DEPARTMENT OF HEALTH AND HUMAN SERVICES FOR HEAD START PROGRAM FOR THE PERIOD OF AUGUST 1, 1999 THROUGH JULY 31, 2000 IN THE AMOUNT OF \$3,273,598; AUTHORIZING THE ADMINISTRATOR TO SIGN THE NOTICE OF GRANT AWARD; AMENDING THE BUDGET AND AUTHORIZING THE ADMINISTRATOR TO SIGN DELEGATE CONTRACTS

WASHTENAW COUNTY BOARD OF COMMISSIONERS

April 21, 1999

WHEREAS, Washtenaw County has administered the Head Start program for eligible children and their families in Washtenaw County for more than ten (10) years;

WHEREAS, the Head Start program plans to serve 543 children of which 339 will be served directly by the county and 204 children through two (2) delegate programs; and

WHEREAS, the federal grant of \$3,273,598 will be used for education, health, training and technical assistance and family services; and

WHEREAS, the Head Start Administrative Team will ensure compliance with all regulations; and

WHEREAS, the Delegates (Ann Arbor Public School and Willow Run Community Schools will receive a total of \$698,797 for the operation of their programs; *and*

WHEREAS, this matter has been reviewed by the Head Start Policy Council, the County Administrator's Office, Corporation Counsel, the Office of Finance, Human Resources, and the Ways and Means Committee

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby

authorizes the signature of the County Administrator on the application to the Department of Health and Human Services for the Head Start Program for the period of August 1, 1999 through July 31, 2000 in the amount of \$3,273,598, as on file with the County Clerk.

BE IT FURTHER RESOLVED that the Washtenaw County Board of Commissioners approves the following actions contingent upon receipt of the grant award in conformity with this application:

1. Authorizing the Administrator to sign the grant award
2. Amending the budget, as attached hereto and made a part hereof.
3. Authorizing the Administrator to sign the contracts with the Delegate agencies; Ann Arbor Public Schools and Willow Run Community schools, upon review and approval of Corporation Counsel to be filed with the County Clerk
4. Authorizing the Administrator to sign the delegate contract with Whitmore Lake Public Schools if negotiations result in Whitmore Lake remaining as a delegate agency upon review of Corporation Counsel to be filed with the County Clerk
