

A RESOLUTION RATIFYING THE SIGNATURE OF THE Chair of the Board ON THE EMPLOYMENT TRAINING AND COMMUNITY SERVICE (ETCS) GROUP'S PROGRAM YEAR (PY) 1998 JTPA TITLE IIA/IIC INCENTIVE GRANT JOB TRAINING PLAN IN THE AMOUNT OF \$12,547 FOR THE PERIOD OF JULY 1, 1998 THROUGH JUNE 30, 1999 AND APPROVING THE BUDGET

WASHTENAW COUNTY BOARD OF COMMISSIONERS

WHEREAS, the ETCS Group requests the ratification of the signature of the County Administrator on the 1998 JTPA Title IIA/IIC Incentive Grant Job Training Plan; and

WHEREAS, the ETCS Group is the administrator and operator of Employment Training programs in Washtenaw County. The ETCS Group is funded by the Job Training Partnership Act, the Department of Labor, and the Michigan Jobs Commission to provide employment training and placement services; and

WHEREAS, the funds will be used for the cost of administering the Title IIA program; and

WHEREAS, the ETCS Group has developed the PY 1998 Title IIA Job Training Plan Modification to serve 141 eligible participants for the period of July 1, 1998 through June 30, 1999; and

WHEREAS, this matter has been reviewed by the Washtenaw County Workforce Development Board, Corporation Counsel, the Finance Department, Human Resources, the County Administrator's Office, and the Ways and Means Committee

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby ratifies the signature of the County Administrator on the 1998 Title IIA/IIC Incentive Grant Job Training Plan for the period of July 1, 1998 through June 30 1999 in the amount of \$12,547 as on file with the County Clerk.

BE IT FURTHER RESOLVED that the Board of Commissioners hereby approves the 1998 Title IIA/IIC Incentive Grant budget as attached hereto and made a part hereof.

BE IT FURTHER RESOLVED that the Board of Commissioners takes the following actions contingent upon receipt of the grant award in conformity with the application:

1. Authorizing the County Administrator to sign the Notice of Grant Award

2. Amending the budget as attached hereto and made a part hereof

3. Authorizing the County Administrator to sign the delegate contracts upon review by Corporation Counsel, to be filed with the County Clerk
