

A RESOLUTION RATIFYING THE COUNTY ADMINISTRATOR'S SIGNATURE ON AN APPLICATION WITH THE STATE OF MICHIGAN, OFFICE OF HIGHWAY SAFETY PLANNING, FOR THE OPERATION SPOTLIGHT GRANT PROGRAM FOR ONE YEAR, COMMENCING OCTOBER 1, 1999 AND ENDING SEPTEMBER 30, 2000 IN THE AMOUNT OF \$12,855

WASHTENAW COUNTY BOARD OF COMMISSIONERS

SEPTEMBER 1, 1999

WHEREAS, the Washtenaw County Sheriff's Department and Washtenaw County have long been proponents of collaborative law enforcement traffic safety enforcement, prevention and educational initiatives regarding alcohol consumption by minors; and

WHEREAS, the Sheriff's Department wishes to further implement educational and prevention initiatives with the County's law enforcement agencies, to impact alcohol consumption by youth issues within the County; and

WHEREAS, the Sheriff's Department is requesting the Board to ratify the County Administrator's signature on a grant application to the State of Michigan, Office of Highway Safety Planning, which is being made available through the OPERATION SPOTLIGHT, Education and Enforcement Campaign, for a period of one year, commencing October 1, 1999 and ending September 30, 2000, in the amount of \$12,855, for the implementation of collaborative prevention and education initiatives which will address the purchase and consumption of alcohol by minors within the County; and

WHEREAS, this matter has been reviewed by the County Administrator's Office, the Finance Department, Corporation Counsel and the Ways and Means Committee;

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners ratifies the County Administrator's signature on a grant application with the State of Michigan, Office of Highway Safety Planning, for the OPERATION SPOTLIGHT Education and Enforcement Funding in the amount of \$12,855, for the period of October 1, 1999 through September 30, 2000, for the implementation of collaborative prevention of purchase and consumption of alcohol by minors initiatives in Washtenaw County, as on file with the County Clerk

BE IT FURTHER RESOLVED that the Board of Commissioners takes the following actions contingent upon receipt of the award in conformity with the application:

1. Authorizes the County Administrator to sign the Notice of Grant Award
 1. Authorizes the County Administrator to sign delegate contract(s), upon review of Corporation Counsel to be filed with the County Clerk
 2. Adopt the budget as attached hereto and made a part hereof.
