

A RESOLUTION RATIFYING THE COUNTY ADMINISTRATOR'S SIGNATURE ON AN APPLICATION IN THE AMOUNT OF \$37,230 WITH THE MICHIGAN JUSTICE TRAINING COMMISSION FOR THE MICHIGAN JUSTICE TRAINING GRANT FUND ACT 302 OF 1982 AS AMENDED FOR THE WASHTENAW ANNUAL RETRAINING PROGRAM FOR THE PERIOD OF JANUARY 1, 2000 THROUGH DECEMBER 31, 2000 (W.A.R.P. 2000)

WHEREAS, the Washtenaw County Sheriff's Office strives to improve its level of service delivery to the community; and

WHEREAS, the Sheriff's Office wishes to further improve deputies' delivery of law enforcement services to the community; and

WHEREAS, the Washtenaw County Sheriff's Office is requesting authorization to submit a grant application to the Michigan Justice Training Commission for funding in the amount of \$37,230, being made available through the Michigan Justice Training Grant Fund for a period of one (1) year, commencing January 1, 2000 and ending December 31, 2000; and

WHEREAS, this funding will be used to retrain deputies and will focus in five core areas (non-lethal force, critical use of force skills and review of policies and procedures, precision driving) and six technical areas (criminal law update, death investigation, interview, cultural diversity, first aid recertification, and liability/risk management), improving deputy skills, in conjunction with staff from Washtenaw Community College.

WHEREAS, this matter has been reviewed by the County Administrator's Office, the Finance Department, Corporation Counsel, and the Ways and Means Committee;

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners ratifies the County Administrator's signature on an application with the Michigan Justice Training Commission, for grant funding in the amount of \$37,230, the Michigan Justice Training Fund, for a period of one year, commencing January 1, 2000 through December 31, 2000 for deputy retraining, as on file with the County Clerk

BE IT FURTHER RESOLVED that the Board of Commissioners takes the following actions contingent upon receipt of the grant award in conformity with the application:

1. Authorizes the County Administrator to sign the Notice of Grant Award.
2. Adopting the budget as attached hereto and made a part hereof.
3. Authorizing the Administrator to sign the delegate contracts upon review of Corporation Counsel to be filed with the County Clerk
