

A RESOLUTION RATIFYING THE COUNTY ADMINISTRATOR'S SIGNATURE ON AN APPLICATION WITH THE BUREAU OF JUSTICE ASSISTANCE, FOR THE BULLETPROOF VEST PARTNERSHIP GRANTS PROGRAM FUNDING IN THE AMOUNT OF \$12,000 FOR FISCAL YEAR 1999

WASHTENAW COUNTY BOARD OF COMMISSIONERS

WHEREAS, the Washtenaw County Sheriff's Department and Washtenaw County wish to maintain the safety of Washtenaw County employees; and

WHEREAS, the Sheriff's Department wishes to protect deputies through the procurement of bulletproof vests through a fifty (50%) percent reimbursement program offered by the Bureau of Justice Assistance; and

WHEREAS, the Washtenaw County Sheriff's Department is requesting authorization to submit a grant application to the Bureau of Justice Assistance, for funding reimbursement in the amount of 50% of the vests' total cost or up to \$6,000, being made available through the Bulletproof Vest Partnership Program for the Federal FY 1999; and

WHEREAS, this funding with the addition of the required Sheriff's Department match money in the amount of \$6,000 (50% of the total program) will be used for the procurement of a minimal number of bulletproof vests, with a reimbursement up to \$6,000 in the first year to protect the Sheriff's Department Deputies in their law enforcement services delivery to the County; and

WHEREAS, this matter has been reviewed by the County Administrator's Office, the Finance Department, Corporation Counsel, and the Ways and Means Committee;

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners ratifies the County Administrator's signature on an application with the Bureau of Justice Assistance, for grant funding in the amount of \$12,000 for 50% reimbursement through the Bulletproof Vest Partnership Program, for Federal Fiscal year 1999, to procure a minimal number of bulletproof vests, as on file with the County Clerk

BE IT FURTHER RESOLVED that the Board of Commissioners approves the following actions, contingent

upon receipt of the grant award:

1. Authorizes the County Administrator to sign the Notice of Grant Award.
2. Amending the 1999 Budget as attached hereto and made a part hereof.
