

A RESOLUTION RATIFYING THE SIGNATURE OF THE CHAIR OF THE BOARD ON THE APPLICATION TO THE FAMILY INDEPENDENCE AGENCY (FIA) FOR STATE EMERGENCY FUNDS (SEF) IN THE AMOUNT OF \$52,684, FOR THE PERIOD OF OCTOBER 1, 1999 THROUGH SEPTEMBER 30, 2000 FOR THE EMPLOYMENT TRAINING AND COMMUNITY SERVICES GROUP; AUTHORIZING THE ADMINISTRATOR TO SIGN THE NOTICE OF GRANT AWARD; AMENDING THE BUDGET AND AUTHORIZING THE ADMINISTRATOR TO SIGN DELEGATE CONTRACTS

WHEREAS, the Employment Training/Community Service Group requests the ratification of the signature of the Chair of the Board on the 2000 State Emergency Funds agreement in the amount of \$52,684 with the FIA; and

WHEREAS, the Employment Training/Community Service Group is the administering agency for the Employment Training and Community Services programs in Washtenaw County, and

WHEREAS, these funds are necessary for the delivery of services to Employment Training/Community Service customers and for the assistance to others in extreme emergencies; and

WHEREAS, the Work First program will use the funds to help enable customers to complete the Work First program and become self-sufficient; and

WHEREAS, the Employment Training/Community Service Group will use the funds for assistance in such cases as payment of utilities, purchase of food and prescriptions, and emergency shelter; and

WHEREAS, the funds must be expended by September 30, 2000; and

WHEREAS, this matter has been reviewed by Corporation Counsel, Finance, Human Resources, the County Administrator's Office, and the Ways and Means Committee.

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby ratifies the signature of the Chair of the Board on the State Emergency Funds application/agreement to the Family Independence Agency in the amount of \$52,684 for the Employment Training/Community Service Group, as on file with the County Clerk, and approves the budget.

BE IT FURTHER RESOLVED that the Board of Commissioners takes the following actions contingent upon receipt of the grant award in conformity with the application:

1. Authorizing the County Administrator to sign the Notice of Grant Award
2. Amending the budget as attached hereto and made a part hereof
3. Authorizing the County Administrator to sign the delegate contracts upon review by Corporation Counsel, to be filed with the County Clerk
