

A RESOLUTION RATIFYING THE SIGNATURE OF THE COUNTY ADMINISTRATOR ON THE PROGRAM YEAR (PY) 1999 JTPA TITLE IIA JOB TRAINING PLAN IN THE AMOUNT OF \$236,475 FOR THE PERIOD OF JULY 1, 1999 THROUGH JUNE 30, 2000 FOR THE EMPLOYMENT TRAINING/COMMUNITY SERVICE GROUP; AUTHORIZING THE ADMINISTRATOR TO SIGN THE NOTICE OF GRANT AWARD, AMENDING THE BUDGET AND AUTHORIZING THE ADMINISTRATOR TO SIGN DELEGATE CONTRACTS

WHEREAS, the Employment Training/Community Service Group requests the ratification of the signature of the County Administrator on the 1999 JTPA Title IIA Job Training Plan; and

WHEREAS, the Employment Training/Community Service Group is the administrator and operator of Employment Training programs in Washtenaw County. The Employment Training/Community Service Group is funded by the Job Training Partnership Act, the Department of Labor, and the Michigan Jobs Commission to provide employment training and placement services; and

WHEREAS, the Employment Training/Community Service Group has developed the PY 1999 Title IIA Job Training Plan to serve 100 adult participants with an allocation of \$236,475 for the period of July 1, 1999 through June 30, 2000; and

WHEREAS, this matter has been reviewed by the Washtenaw County Workforce Development Board, Corporation Counsel, the Finance Department, Human Resources, the County Administrator's Office, and the Ways and Means Committee

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby ratifies the signature of the County Administrator on the 1999 Title IIA Job Training Plan for the period of July 1, 1999 through June 30 2000 in the amount of \$236,475 for the Employment Training/Community Services Group, as on file with the County Clerk.

BE IT FURTHER RESOLVED that the Board of Commissioners takes the following actions contingent upon receipt of the grant award in conformity with the application:

1. Authorizing the County Administrator to sign the Notice of Grant Award
2. Amending the budget as attached hereto and made a part hereof
3. Authorizing the County Administrator to sign the delegate contracts upon review by Corporation Counsel, to be filed with the County Clerk
