

A RESOLUTION RATIFYING THE SIGNATURE OF THE CHAIR OF THE BOARD ON THE 1999 TITLE IIB SUMMER YOUTH EMPLOYMENT AND TRAINING PROGRAM PLAN (SYETP) TO THE MICHIGAN JOBS COMMISSION (MJC) IN THE AMOUNT OF \$316,122 FOR THE PERIOD OCTOBER 1, 1999 THROUGH SEPTEMBER 30, 2000 FOR THE EMPLOYMENT TRAINING/COMMUNITY SERVICES GROUP; AUTHORIZING THE ADMINISTRATOR TO SIGN THE NOTICE OF GRANT AWARD; AMENDING THE BUDGET, AND AUTHORIZING THE ADMINISTRATOR TO SIGN DELEGATE CONTRACTS

WHEREAS, the ETCS Group has received notification from the MJC of the 1999 Title IIB final allocation in the amount of \$316,122; and

WHEREAS the Michigan Jobs Commission requires the submission of a Job Training Plan Modification/Revision Approval Request for the 1999 Title IIB; and

WHEREAS, the Title IIB plan has been developed to serve 125 eligible youth; and

WHEREAS, the plan has been developed with the following goals and objectives:

- Improvement in school retention and completion;
- Improvement in academic performance, including mathematics and reading comprehension;
- Improvement in employability skills;
- Coordination with other community service organizations such as local educational agencies, law enforcement agencies, and drug and alcohol abuse prevention and treatment programs;
- Enhancement of basic skills of youth;
- Encouragement of school completion, or enrollment in supplemental or alternative school programs;
- Providing eligible youth with exposure to the world of work; and
- Enhancement of citizenship skills of youth

WHEREAS this matter has been reviewed by the Washtenaw County Workforce Development Board, the County Administrator's Office, Corporation Counsel, Finance, Human Resources, and the Ways and Means Committee

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby ratifies the signature of the Chair of the Board on the 1999 Title IIB Summer Youth Employment Training Program Plan to the Michigan Jobs Commission for the period of October 1, 1999 through September 30, 2000, in the amount of \$316,122 for the Employment Training/Community Services Group, as on file with the County Clerk

BE IT FURTHER RESOLVED that the Board of Commissioners takes the following actions contingent upon receipt of the grant award in conformity with the application:

- 1. Authorizing the Administrator to sign the Notice of Grant Award
- 2. Amending the budget as attached hereto and made a part hereof
- 3. Authorizing the Administrator to sign the delegate and lease contracts upon review of Corporation Counsel to be filed with the County Clerk
