

A RESOLUTION RATIFYING THE SIGNATURE OF THE CHAIR OF THE BOARD ON THE FISCAL YEAR (FY) 2000 LOW INCOME HOME ENERGY ASSISTANCE PROGRAM (LIHEAP) APPLICATION TO THE MICHIGAN FAMILY INDEPENDENCE AGENCY (FIA) FOR THE PERIOD OF SEPTEMBER 1, 1999 THROUGH AUGUST 31, 2000 IN THE AMOUNT OF \$158,528 FOR THE EMPLOYMENT TRAINING AND COMMUNITY SERVICES (ETCS) GROUP; AUTHORIZING THE ADMINISTRATOR TO SIGN THE NOTICE OF GRANT AWARD; AMENDING THE BUDGET AND AUTHORIZING THE COUNTY ADMINISTRATOR TO SIGN THE DELEGATE CONTRACTS

WHEREAS, the Employment Training/Community Service Group has operated a Home Weatherization program since 1975; and

WHEREAS, the Michigan FIA has allocated \$158,528 in LIHEAP funding to provide emergency energy-related repairs for eligible residents of Washtenaw County; and

WHEREAS, this funding allows the Employment Training/Community Service Group Weatherization program to service customers with major repairs such as new roofs, furnace tune-ups and replacement; and

WHEREAS, this funding also enhances the ability of the Employment Training/Community Service Group Weatherization program to address health and safety issues resulting from faulty hot water tanks and furnaces; and

WHEREAS, this matter has been reviewed by the Washtenaw County Workforce Development Board, the County Administrator's Office, Corporation Counsel, Finance, Human Resources, and the Ways and Means Committee

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby ratifies the signature of the Chair of the Board on the application to the Michigan FIA in the amount of \$158,528 for LIHEAP for the period of September 1, 1999 through August 31, 2000 for the Employment Training/Community Services Group, as on file with the County Clerk

BE IT FURTHER RESOLVED that the Board of Commissioners takes the following actions contingent upon receipt of the grant award in conformity with the application:

1. Authorizing the County Administrator to sign the Notice of Grant Award
2. Amending the budget as attached hereto and made a part hereof
3. Authorizing the County Administrator to sign the delegate contracts upon review by Corporation Counsel, to be filed with the County Clerk
