

A RESOLUTION AUTHORIZING THE COUNTY ADMINISTRATOR TO SIGN THE CONTRACT WITH SECURECARE, INC. TO PROVIDE MEDICAL SERVICES FOR THE INMATES IN THE WASHTENAW COUNTY CORRECTIONAL FACILITY FOR THE PERIOD JANUARY 1, 2000 THROUGH DECEMBER 31, 2004 IN THE AMOUNT OF \$1,106,290 FOR THE FIRST YEAR

WASHTENAW COUNTY BOARD OF COMMISSIONERS

WHEREAS, the Washtenaw County Sheriff's Department is responsible for the medical and psychiatric treatment of all inmates; and

WHEREAS, professional medical care is needed to ensure the health and safety of all inmates; and

WHEREAS, the Sheriff's Department has contracted with SecureCare, Inc. since 1994 and received bids for medical services and again, after intense review, selected SecureCare Inc.; and

WHEREAS, the Sheriff's Department and Community Mental Health have worked collaboratively on this initiative to provide better services at a lesser cost; and

WHEREAS, this contract will provide medical services for the Washtenaw County Correctional Facility from January 1, 2000 to December 31, 2004; and

WHEREAS, the compensation of the contract for the first year is \$1,106,290 and the remaining four years of the contract will be adjusted according to the Medical Consumer Price Index; and

WHEREAS, Community Mental Health has partnered with the Sheriff's Department and will provide the psychiatric services for the inmates at a cost of approximately \$90,000; and

WHEREAS, determined in the 2000-2001 budget process funding for projects will be dealt with as a comprehensive package with the results of the Northwestern University study; and

WHEREAS, this matter has been reviewed by Corporation Counsel, the Finance Department, Human Resources, the County Administrator's Office and the Ways & Means Committee;

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby authorizes the County Administrator to sign the contract with SecureCare, Inc. for Medical Services for the period of January 1, 2000 to December 31, 2004 in the amount of \$1,106,290 in 2000 and adjusted for years 2001-2004, as on file with the County Clerk

BE IT FURTHER RESOLVED that the Washtenaw County Board of Commissioners hereby authorizes the County Administrator to sign interdepartmental agreements between the Sheriff's Department and Community Mental Health for psychiatric services to inmates upon approval from Corporation Counsel to be filed with the County Clerk and other delegate contracts that may result from this agreement.
