

A RESOLUTION RATIFYING THE SIGNATURE OF THE ADMINISTRATOR ON THE APPLICATION AGREEMENT WITH THE MICHIGAN FAMILY INDEPENDENT AGENCY FOR THE JUVENILE JUSTICE REINTEGRATION PROGRAM FOR THE PERIOD OCTOBER 1, 1999 THROUGH SEPTEMBER 30, 2000, IN THE AMOUNT OF \$148,724 TO PROVIDE REINTEGRATION SERVICES TO STATE DELINQUENCY WARDS AND COURT WARDS UNDER FIA SUPERVISION; AUTHORIZE THE ADMINISTRATOR TO SIGN THE NOTICE OF GRANT AWARD; TO CONTINUE THE POSITIONS CREATED, AMEND THE BUDGET AND AUTHORIZE THE ADMINISTRATOR TO SIGN DELEGATE CONTRACTS

WHEREAS, the Michigan Family Independence Agency and the Washtenaw County Trial Courts, Family Division have identified a need for a continuum of services for youth supervised by or committed to the Michigan Family Independence Agency; and

WHEREAS, The Michigan Family Independent Agency and the Washtenaw County Trial Courts, Family Division have agreed to continue to provide said services; and

WHEREAS, The Washtenaw County Trial Courts, Family Division is requesting authorization to continue providing said services; and

WHEREAS, the Michigan Family Independence Agency has agreed to pay the Washtenaw County Trial Courts, Family Division \$ 148,724 to perform said services; and

WHEREAS, to fulfill the contractual obligations, the Washtenaw County Trial Courts, Family Division requests the Board to renew the offer from the Michigan Family Independence Agency; and

WHEREAS, this matter has been reviewed by the County Administrator, the Finance Department, Human Resources, Corporation Counsel and the Ways and Means Committee

NOW THEREFORE BE IT RESOLVED THAT the Washtenaw County Board of Commissioners hereby ratifies the signature of the Administrator on the application agreement with the Michigan Family Independence Agency for the Juvenile Justice Reintegration Program for the period of October 1, 1999 through September 30, 2000, in the amount of \$ 148,724 for the Trial Court-Family Division, as on file with the County Clerk.

BE IT FURTHER RESOLVED that the Board of Commissioners hereby takes the following actions contingent upon receipt of the grant award in conformity with the application:

1. Authorizing the Administrator to sign the Notice of Grant Award
2. Amending the budget, as attached hereto and made a part hereof
3. Authorizing the continuation of the existing two (2) full time grant status positions for the duration of the grant, with the possibility of extending these positions for an additional one (1) year through Administrative Authority.
4. Authorizing the Administrator to sign delegate contracts upon review of Corporation Counsel to be filed with the County Clerk
