

A RESOLUTION RATIFYING THE CHAIR OF THE BOARD'S SIGNATURE ON THE PARTNERSHIP FOR ADULT LEARNING (PAL) THREE-YEAR LOCAL PLAN (OCTOBER 1, 2000 THROUGH SEPTEMBER 30, 2003) TO THE MICHIGAN DEPARTMENT OF CAREER DEVELOPMENT (MDCD) FOR FIRST-YEAR FUNDING IN THE AMOUNT OF \$349,881 FOR THE PERIOD OF OCTOBER 1, 2000 THROUGH SEPTEMBER 30, 2001; AUTHORIZING THE ADMINISTRATOR TO SIGN THE NOTICE OF GRANT AWARD; AMENDING THE BUDGET; AND AUTHORIZING THE COUNTY ADMINISTRATOR TO SIGN DELEGATE AND LEASE CONTRACTS

WHEREAS, the Washtenaw County Michigan Works! Agency/ETCS Group has received money for the purpose of developing training services to accelerate adult student learning, and

WHEREAS, the funds are to be used to prepare customers for employment or better employment by way of education to work or education to education to work; and

WHEREAS, these services are to be a component of the career development system and address the needs of the employer community in Washtenaw County; and

WHEREAS, the target audience for the Partnership for Adult Learning (PAL) funded services will be adults who meet the general eligibility criteria and have one of the following goals: achievement of a high school diploma or GED, enroll in post-secondary education or job training, obtain employment, retain employment, and advance to better employment; and

WHEREAS, this matter has been reviewed by the Ways and Means Committee, the Washtenaw County Community Action Board, the County Administrator's Office, Corporation Counsel, the Finance Department, and the Human Resources Department

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby ratifies the signature of the Chair of the Board Administrator on the ETCS Group's Partnership for Adult Learning 3-Year Local Plan to the Michigan Department of Career Development for first-year funding in the amount of \$349,881 for the period of October 1, 2000 through September 30, 2001, as on file with the County Clerk.

BE IT FURTHER RESOLVED that the Board of Commissioners hereby takes the following actions contingent upon receipt of the grant award in conformity with the application:

1. Authorizing the County Administrator to sign the Notice of Grant Award
2. Amending the budget as attached hereto and made a part thereof
3. Authorizing the County Administrator to sign the delegate and lease contracts upon review and approval of Corporation Counsel, to be filed with the County Clerk.
