

A RESOLUTION RATIFYING THE ELECTRONIC SUBMISSION OF THE APPLICATION TO THE BUREAU OF JUSTICE ASSISTANCE FOR THE LOCAL LAW ENFORCEMENT BLOCK GRANTS PROGRAM FOR THE SHERIFF'S DEPARTMENT IN THE AMOUNT OF \$101,391 FOR THE PERIOD OCTOBER 1, 2001 THROUGH SEPTEMBER 30, 2002; AUTHORIZING THE ADMINISTRATOR TO SIGN THE NOTICE OF GRANT AWARD; AMENDING THE BUDGET AND AUTHORIZING THE ADMINISTRATOR TO SIGN DELEGATE CONTRACTS

WHEREAS, the Washtenaw County Sheriff's Department and Washtenaw County have diligently maintained efforts to better serve the citizens of Washtenaw County; and

WHEREAS, the Sheriff's Department wishes to further enhance its delivery of law enforcement services to the community, within the realm of community oriented policing; and

WHEREAS, the Washtenaw County Sheriff's Department has submitted an electronic application for a grant award from the Bureau of Justice Assistance, for funding in the amount of \$91,252 through the Local Law Enforcement Block Grants Program; and

WHEREAS, this funding, with the addition of the required matching funds in the amount of \$10,139, which is available within the Sheriff's budget, will be used to update/upgrade various equipment for deputies at the Sheriff's Department to improve law enforcement services delivery to the County; and

WHEREAS, this matter has been reviewed by the County Administrator's Office, the Finance Department, Corporation Counsel, and the Ways and Means Committee;

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby ratifies the electronic submission of the application to the Bureau of Justice Assistance for the Local Law Enforcement Block Grants Program for grant funding in the amount of \$91,252 for a total program of \$101,391 for the Sheriff's Department, as on file with the County Clerk

BE IT FURTHER RESOLVED that the Board of Commissioners takes the following actions contingent upon receipt of the grant award in conformity with the application:

1. Authorizing the Administrator to sign the Notice of Grant Award
2. Amend the budget as attached hereto and made a part hereof
3. Authorizing the Administrator to sign delegate contracts, upon review of Corporation Counsel to be filed with the County Clerk
