

A RESOLUTION RATIFYING THE CHAIR OF THE BOARD'S SIGNATURE ON THE EMPLOYMENT TRAINING COMMUNITY SERVICES (ETCS) GROUP'S FISCAL YEAR (FY) 2001 DISPLACED HOMEMAKER PROGRAM (DHP) PLAN APPLICATION TO THE MICHIGAN DEPARTMENT OF CAREER DEVELOPMENT (MDCD), IN THE AMOUNT OF \$81,000, FOR THE PERIOD OF OCTOBER 1, 2001 THROUGH SEPTEMBER 30, 2002; AUTHORIZING THE COUNTY ADMINISTRATOR TO SIGN THE NOTICE OF GRANT AWARD; AMENDING THE BUDGET, AND AUTHORIZING THE COUNTY ADMINISTRATOR TO SIGN DELEGATE CONTRACTS.

WHEREAS, the Employment Training Community Services Group has administered the Displaced Homemaker Program for five years in Washtenaw County; and

WHEREAS, this year the plan is to provide employment training services to one hundred fifty-two eligible individuals; and

WHEREAS, the State Selected Providers for the Washtenaw County are Help Source Inc. and The Women's Center of America; and

WHEREAS, eligibility for this program is determined as an individual who has been providing unpaid services to family members in the home, and who has been dependent on the income of another family member but is no longer supported by that income, and

WHEREAS, further eligibility requirements include the individual being unemployed or underemployed and experiencing difficulty in obtaining or upgrading employment; and

WHEREAS, eligible candidates are serviced through three levels of services: (1) core services, (2) intensive services, and (3) training services; and

WHEREAS, the services provided may include, among others: vocational assessment, vocational counseling, job-seeking skills training, job placement assistance, direct job development and placement assistance, referrals to community resources; and

WHEREAS, this matter has been reviewed by the Washtenaw County Workforce Development Board, Corporation Counsel, the Finance Department, the Human Resources Department, the County Administrator's Office, and the Ways and Means Committee

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby ratifies the Chair of the Board's signature on the Employment Training Community Services (ETCS) Group's Program Year 2001 Displaced Homemaker Program Plan application to the Michigan Department of Career Development in the amount of \$81,000 for the period of October 1, 2001 through September 30, 2002, as on file with the County Clerk

BE IT FURTHER RESOLVED that the Board of Commissioners takes the following actions contingent upon receipt of the grant award, in conformity with the application:

1. Authorizing the County Administrator to sign the Notice of Grant Award
2. Amending the budget, as attached hereto and made a part thereof
3. Authorizing the County Administrator to sign the delegate contracts upon review by Corporation Counsel, to be filed with the County Clerk.
