

A RESOLUTION AUTHORIZING THE ELECTRONIC SUBMITTAL OF AN APPLICATION WITH THE BUREAU OF JUSTICE ASSISTANCE, FOR THE BULLETPROOF VEST PARTNERSHIP GRANTS PROGRAM IN THE AMOUNT UP TO \$15,840 FOR FISCAL YEAR 2002 FOR THE SHERIFF'S DEPARTMENT

WASHTENAW COUNTY BOARD OF COMMISSIONERS

WHEREAS, the Washtenaw County Sheriff's Department and Washtenaw County wish to maintain the safety of Washtenaw County employees; and

WHEREAS, the Sheriff's Department wishes to protect deputies through the procurement of bulletproof vests through a fifty (50%) percent reimbursement program offered for the fourth year by the Bureau of Justice Assistance; and

WHEREAS, the Washtenaw County Sheriff's Department is requesting authorization to electronically submit a grant application to the Bureau of Justice Assistance, for funding reimbursement in the amount up to \$7,920, or 50% of the vests' total cost, being made available through the Bulletproof Vest Partnership Program; and

WHEREAS, this funding with the addition of the required Sheriff's Department match money in the amount of \$7,920 (50%) will be used for the procurement of a number of bulletproof vests to protect the Sheriff's Department Deputies in their law enforcement services delivery to the County; and

WHEREAS, the required Sheriff's Department match funding is available within the Sheriff's existing supplies budget; and

WHEREAS, this matter has been reviewed by the County Administrator's Office, the Finance Department, Corporation Counsel, and the Ways and Means Committee.

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners authorizes the County Administrator to electronically submit an application with the Bureau of Justice Assistance, for grant funding in the amount up to \$15,840 with 50% reimbursement through the Bulletproof Vest Partnership Program, for Federal Fiscal year 2002, to procure a minimal amount of bulletproof vests.

BE IT FURTHER RESOLVED that the Board of Commissioners approves the following actions, contingent upon receipt of the grant award:

1. Authorizes the Chair of the Board and/or County Administrator to sign the Notice of Grant Award.
2. Amend the 2002 Budget as attached hereto and made a part hereof
3. Authorizing the Administrator to sign the delegate contracts upon review of Corporation Counsel to be filed with the County Clerk
