

A RESOLUTION AUTHORIZING THE COUNTY ADMINISTRATOR TO SIGN THE FISCAL YEAR 2002 STATE DOMESTIC PREPAREDNESS EQUIPMENT GRANT AGREEMENT WITH THE STATE OF MICHIGAN FOR THE PERIOD OF FEBRUARY 4, 2002 THROUGH DECEMBER 31, 2002 IN THE AMOUNT OF \$65,616.

WASHTENAW COUNTY BOARD OF COMMISSIONERS

WHEREAS, the United States Department of Justice has established a grant for the purpose of enhancing the chemical, biological and radiological response capabilities of local public safety organizations; and

WHEREAS, this grant will enhance public safety response capabilities in the event of an act of domestic terrorism or incident involving weapons of mass destruction; and

WHEREAS, the Washtenaw County Emergency Medical Services Commission created a Bioterrorism Committee in April of 2000, charged with identification of all pertinent response resources; and

WHEREAS, the Washtenaw County Hazardous Materials Response Team and Huron Valley Ambulance Hazardous Materials Response Group has several important and clearly identified response equipment needs; and

WHEREAS, the United States Department of Justice, through the Michigan State Police has tentatively awarded this response equipment grant to Washtenaw County for \$65,616; and

WHEREAS, the Washtenaw County Emergency Medical Service Commission, Bioterrorism Committee, and Local Emergency Planning Committee have all unanimously recommended to the Board of Commissioners that this money be dedicated towards the hazardous materials response equipment needs of the Washtenaw County Hazardous Materials Response Team and the Huron Valley Ambulance Hazardous Materials Response Group; and

WHEREAS, this matter has been reviewed by the County Administrator, Corporation Counsel, Human Resources, the Finance Office, and the Ways and Means Committee.

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners authorizes the County Administrator to sign the FY2000 State Domestic Preparedness Equipment Grant Agreement with the State of Michigan.

BE IT FURTHER RESOLVED that the Washtenaw County Board of Commissioners establishes a budget of \$65,616 as attached hereto and made a part hereof.
