

A RESOLUTION RATIFYING THE SUBMISSION OF AN ELECTRONIC APPLICATION WITH THE BUREAU OF JUSTICE ASSISTANCE, FOR THE LOCAL LAW ENFORCEMENT BLOCK GRANTS PROGRAM FOR THE SHERIFF'S OFFICE IN THE AMOUNT OF \$85,792 FOR THE PERIOD OF OCTOBER 1, 2002 THROUGH SEPTEMBER 30, 2003; AUTHORIZING THE ADMINISTRATOR TO SIGN THE NOTICE OF GRANT AWARD; AMENDING THE BUDGET AND AUTHORIZING THE ADMINISTRATOR TO SIGN THE DELEGATE CONTRACTS

WHEREAS, the Washtenaw County Sheriff's Department and Washtenaw County have diligently maintained efforts to better serve the citizens of Washtenaw County; and

WHEREAS, the Sheriff's Department wishes to further enhance its delivery of law enforcement services to the community, within the realm of community oriented policing; and

WHEREAS, the Washtenaw County Sheriff's Department has submitted an electronic application for a grant award from the Bureau of Justice Assistance, for funding in the amount of \$77,213 being made available through the Local Law Enforcement Block Grants Program; and

WHEREAS, this funding with the addition of the required matching funds in the amount of \$8,579, which has been allocated within the Sheriff's existing operating budget, will be used to update/upgrade various equipment for deputies at the Sheriff's Department to improve law enforcement services delivery to the County; and

WHEREAS, this matter has been reviewed by the County Administrator's Office, the Finance Department, Human Resources, Corporation Counsel, and the Ways and Means Committee;

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners ratify the approval of the County Administrator to submit an electronic application with the Bureau of Justice Assistance for grant funding in the amount of \$77,213 for a total program amount of \$85,792 through the Local Law Enforcement Block Grants Program.

BE IT FURTHER RESOLVED that the Board of Commissioners approves the following actions:

1. Authorizing the Administrator to sign the Notice of Grant Award
2. Amend the budget as attached hereto and made a part hereof
3. Authorizing the Administrator to sign delegate contracts, upon review of Corporation Counsel to be filed with the County Clerk
