

A RESOLUTION AUTHORIZING THE COUNTY ADMINISTRATOR'S SIGNATURE ON THE APPLICATION TO THE DEPARTMENT OF HEALTH AND HUMAN SERVICES FOR THE HEAD START PROGRAM FOR THE PERIOD OF AUGUST 1, 2006 THROUGH JULY 31, 2007 IN THE AMOUNT OF \$93,750 FOR THE ORAL HEALTH GRANT PROGRAM; AUTHORIZING THE ADMINISTRATOR TO SIGN THE NOTICE OF GRANT AWARD; AUTHORIZING THE ADMINISTRATOR TO SIGN EACH SUPPLEMENTAL FUNDING AWARD THROUGHOUT THE DURATION OF THE FOUR YEAR ORAL HEALTH GRANT WITH A FUNDING PERIOD OF DECEMBER 31, 2005 THROUGH DECEMBER 31, 2009; AND APPROVING THE HEAD START ORAL HEALTH BUDGET.

WHEREAS, Washtenaw County has administered the Head Start program for eligible children and their families in Washtenaw County for more than forty (40) years;

WHEREAS, the Head Start program continues to serve 561 children of which 209 are served directly by the county and 352 through four delegate programs and one child care partnership; and

WHEREAS, oral health for Head Start children and their families is a critical concern for Head Start as well as the County, as recognized in the County health Improvement Plan; and

WHEREAS, on October 3, 2005 the Board of Commissioner approved in resolution #05-0176 the original application for the new Oral Health program which was a request for a one year grant for \$75,000 in federal funding and \$18,750 being contributed in in-kind local match; and

WHEREAS, the response to this original Oral Health program grant application was extremely favorable with an award being granted for a forty-eight month program with an annual federal award of \$75,000 for a total federal award of \$300,000 and in-kind match of \$75,000; and

WHEREAS, the annual Federal grant of \$75,000 for this Oral Health initiative will provide extensive training to parents, staff and the community as well as additional oral health services to Head Start children and their families; and

WHEREAS, required local match will be provided by HOPE Dental clinic, the University of Michigan School of Dentistry, local dentists, and university interns; and

WHEREAS, HOPE Dental Clinic and the University of Michigan Dental School have collaborated in this effort and will serve as partners in providing service and training; and

WHEREAS, the Head Start Management Team will ensure compliance with all regulations; and

WHEREAS, this matter has been reviewed by the Head Start Policy Council, the County Administrator's Office, Corporation Counsel, the Office of Finance, Human Resources, and the Ways and Means Committee.

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby authorizes the County Administrator to sign the application to the Department of Health and Human Services for the Oral Health Initiative, for the period of August 1, 2006 through July

31, 2007 in the amount of \$93,750 to be filed with the County Clerk.

BE IF FURTHER RESOLVED that the Board of Commissioners takes the following actions contingent upon receipt of the grant award in conformity with the application:

1. Authorizing the County Administrator to sign the Notice of Grant Award
2. Authorizing the County Administrator to sign each supplemental funding award through the duration of the four year Oral Health grant award
3. Authorizing the Administrator to sign the delegate contracts upon review of Corporation Counsel to be filed with the County Clerk
4. Amending the budget, as attached hereto and made a part hereof
