## WASHTENAW COUNTY BOARD OF COMMISSIONERS

## MARCH 7, 2001

WHEREAS, the Washtenaw County Prosecutor's Office wishes to continue a pilot juvenile diversion/restoration program for children at risk in Washtenaw County. The three priorities of this program will be public safety, accountability, and competency development, recognizing victim and offender restoration as critical goals of community justice; and

WHEREAS, the goal of the Juvenile Diversion/Restoration Program is to serve 150 juvenile offenders through the diversion program and an additional 100 at-risk juveniles through the mentoring component during the grant year; and

WHEREAS, referrals to the Juvenile Diversion/Restoration Program come from law enforcement, school administrators, and school liaison officers through the petition request process; and

WHEREAS, juveniles meeting the program criteria and the juvenile's family assist the diversion specialist in developing the juvenile's restoration plan; and

WHEREAS, the restoration plans address the special needs of the juvenile, such as the need for education skills development, counseling, anger management, or substance abuse treatment.

WHEREAS, all participants are required to complete some form of age-appropriate community service; and

WHEREAS, the total program amount of the Juvenile Diversion/Restoration Program is \$208,753, of which \$104,377 is in federal funds and \$104,376 in local match; and

WHEREAS, the local match will be incorporated in the 2002-2003 budget; and

WHEREAS, this matter has been reviewed by the County Administrator's Office, the Finance Department, Corporation Counsel and the Ways and Means Committee

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners ratifies the signature of the County Administrator on a grant

continuation application with the State of Michigan, Office of Drug Control Policy, Department of Community Health for the Byrne Memorial Grant Funding Program.

BE IT FURTHER RESOLVED that the Board of Commissions takes the following action contingent upon receipt of the award in conformity with the application:

- 1. Authorizes the County Administrator to sign the Notice of Grant Award
- 2. Amending the budget as attached hereto and made a part hereof
