Michael Moran, Ann Arbor Township Supervisor, commented on the police services fees and said that the townships and the county have different views on the structure of the fees. He suggested that the county move to a cost structure that is based on incremental costs.

New Business:

Revenue & Record Keeping Community of Interest:

Treasurer – Delinquent Tax Borrowing Resolution

Comm. Bergman seconded by Comm. Solowczuk moved to recommend that the Board of Commissioners approve the Resolution to borrow against anticipated delinquent 2004 real property taxes.

Treasurer, Catherine McClary, addressed the Board regarding the delinquent tax resolution. She said that the resolution allows the Treasurer's office to borrow against the delinquent taxes owed since those taxes which are not paid are sent to the county. The loan permits the county to pay the local jurisdictions.

Comm. Irwin asked about the impact of the early tax collection on delinquencies. Catherine McClary stated that it is still early to tell, but it appears that it will be higher than normal. Comm. Irwin asked what sort of interest is paid for the loan. Catherine McClary stated that the monies are borrowed against the County's credit which keeps the interest lower.

Comm. Prater asked when the loan would be paid to the townships. Catherine McClary said that would be processed and paid in about 2-3 weeks. She also commented that the Treasurer's report would be modified in the next few months to include more information.

Comm. Prater, supported by Comm. Solowczuk moved that the Delinquent Tax Borrowing Resolution be added to the May 5, 2005 Board of Commissioners Meeting Agenda. The motion passed unanimously by voice vote.
