Report of the Administrator

A. RFP Vendor Preference Discussion

Local Vendor Preference presented by Curt Hedger. Hedger discussed cases that had fallen on both sides of the issue. He stated that these preferences are often challenged under the privileges and immunities clause and equal protection.

Comm. Ping asked about possibly drafting a policy.

Comm. Gunn stated that she does not want to open this can of worms. Hedger stated that he would not be surprised to see more of these local vendor preference challenges due to the economy.

Comm. Ping seconded by Comm. Lovejoy Roe moved to direct Corporation Counsel to draft a policy on local vendor preference pertaining to construction.

Comm. Smith stated that it is important to recognize that this is a metropolitan economy. He stated that he feels that the mission is appropriate. Comm. Smith asked if thing intangible in nature can be stated in the current policy. He added that a design for the RFP process can be done. Hedger stated that the current language does allow some flexibility.
