Prater moved to recommend that the Board of Commissioners approve the resolution authorizing the County Administrator to sign the Washtenaw Urban County Annual Action Plan for July 1, 2010 to June 30, 2011 for the U.S. Department of Housing and Urban Development; authorizing the County Administrator to sign the Notice Grant Award; approve the budgets in the total amount of \$4,552,181; and authorizing the County Administrator to sign the delegate contracts be adopted.

Equalization Report

Raman Patel presented the annual Equalization Report (on file in County Clerk's office).

Comm. Gunn stated that this is good news and added that she would like to put funds aside at this time. She added that someone in the state is proposing to do away with personal property tax.

Comm. Ouimet stated that he has been talking about industrial property for a long time. He asked what the impact on commercial property would be going forward. Patel stated that he still feels that commercial property will continue to decline. Comm. Ouimet stated that the County should keep this in mind from a budgeting standpoint. Patel reported that Washtenaw is much better off than other counties. Comm. Ouimet stated that the question on the commercial side is whether adequate cash flow will exist. He added that there are also positives in this report.

Comm. Judge thanked the Equalization staff. She asked if the 4% decrease shown under Commercial is worse because of the new Industrial class rules. Patel reported that it is and that this is a good observation.

Comm. Bergman stated that she would like to thank the Equalization staff. She stated that funds that come in over budget should not be spent.

Comm. Schwartz asked if there was \$900 million on appeal. Patel stated that this is correct. Comm. Schwartz stated that some refunds will be due to citizens. He added that the wealth of citizens has taken a hit.

Comm. Smith stated that he would like to thank the Equalization team. He added that this is only half of the equation with the budget. Comm. Smith stated that savings from the budget still need to be accrued. He added that interest earnings are down, police service costs, and jail staffing costs still loom large. Comm. Smith stated that any windfall should be approached with extreme caution.

Comm. Gunn seconded by Comm. Prater moved to recommend that the Board of Commissioners approve the resolution approving the 2010 Washtenaw County Equalization Report be adopted.

Discussion took place on the proposed amendment.

Comm. Prater seconded by Comm. Judge moved to call the question on the amendment. Roll call vote: YEAS: 5 NAYS: 6 (Comms. Bergman, Gunn, Irwin, Peterson, Schwartz, and Smith) ABSENT: 0. Motion failed.
