Budget Strategy for 2001, which includes

- A representative population on the next education reimbursement count would increase revenue by \$250,000
- BOC has CCF reserve of \$300,000 originally allocated for operations of new Detention/Day Treatment Center available.
- Monitor and report to the BOC on quarterly basis to approve transfers from the CCF reserve (\$300,000) and Building Reserve Fund if necessary.
- Bring a comprehensive plan to the BOC as part of the 2002/03 Budget process.
- Benchmark other counties for numbers of youth, length of stay, programs provided, and costs.

Goal for 2001

• To build public confidence and improve results for children, families, and the community

Plan of Action - Next Steps, which includes:

- National Center for Juvenile Justice Study January 2001
- Recommendations by March 2001
- Collaboration with other county departments
- Form a committee of managers, legal staff, and line staff to evaluate the recommendations derived from the Plante & Moran study and establish an implementation plan.
