-Ballot Question Committees-**

A Ballot Question Committee must submit the following statements in 2018 unless it is eligible for and requests a reporting waiver prior to the close of the books for the applicable filing deadline.

**2017 ANNUAL CAMPAIGN FINANCE STATEMENT REQUIRED**

Public Act 119 of 2017 has reinstated the annual reporting requirement. A 2017 Annual Statement is required to be filed by all committees EXCEPT those committees that maintain a reporting waiver or file a Post-Election Campaign Finance Statement in December, 2017.

File the following statements. If your committee supports or opposes a ballot proposal on a 2018 ballot, it must file a pre- and post- election statement in accordance with the election date listed below in lieu of a quarterly statement.

**May 8, 2018 Election:**

*\*\*Late Contribution Reports Period from: April 23-May 5, due 48 hours after receipt.*

**August 7, 2018 Election:**

Pre-Election	July 22, 2018	July 27, 2018
Post-Election	August 27, 2018	September 6, 2018

*\*\*Late Contribution Reports Period from: July 23-August 4, due 48 hours after receipt.*

**November 6, 2018 Election:**

Pre-Election	October 21, 2018	October 26, 2018
Post-Election	November 26, 2018	December 6, 2018

*\*\*Late Contribution Reports Period from: October 22-November 3, due 48 hours after receipt.*

*\*\* Late contribution reports are required when \$2,500 or more is contributed by a single contributor during 15<sup>th</sup> to 3<sup>rd</sup> day prior to election. They are NOT waived by the reporting waiver.*
