Shall the authorized charter millage for ad valorem taxes for the Charter Township of Ann Arbor be increased by 0.7 mills (\$.70 per \$1,000 of taxable value) for the Township's fiscal years 2004 through 2023, inclusive, for purposes of funding the purchase of development rights for the permanent preservation of farmland and open space throught the Township, to be levied upon taxable real and tangible personal property within the Township, which levy will raise in the first year an estimated \$278,083, which together with the Township's existing levies, will result in a total authorized charter millage established at 3.50 mills (\$3.50 per \$1,000 of taxable value), which total levy will raise in the first year an estimated \$1,362,346.
