- One-and Two-Family dwellings when the total building heating/cooling system input rating is 375,000 BTU's or less.
- Alterations and repair work determined by the mechanical official to be of a minor nature.
- Business, mercantile, and storage buildings having HVAC equipment only, with one fire area and not less than 3,500 square feet.
- Work completed by a governmental subdivision or state agency costing less than \$15,000.00

Plans are required for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to 1980 PA 299 and shall bear that architect's or engineer's seal and signature.

ITEM #2 RESIDENTIAL HEATING SYSTEM:

This item is used for the installation of a heating system in a new residential structure. Items #9;Gas Piping and #18;Duct, **SHOULD NOT BE** charged. Replacement systems should be itemized.

ITEM #4 RESIDENTIAL BOILER:

A Residential Boiler must be installed by a licensed boiler installer.

ITEM #13 TANKS:

A homeowner must own tank to install. If the homeowner does not own tank, a licensed mechanical contractor must install tank.

IX. Instructions for Completing Application

GENERAL: Mechanical work shall not be started until the application for permit has been filed with Washtenaw County Building Inspection. All installations shall be in conformance with the State Mechanical Code. **No work shall be concealed until it has been inspected and approved.**

The inspection telephone number will be provided on the permit form. When ready for inspection, call Washtenaw County Building Inspection providing as much advance notice as possible. The inspection department will need the **job address** and **permit number**.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELLED PERMITS CANNOT BE REFUNDED OR REINSTATED.**
