**3. PUBLIC FORUMS:**

a. Planning

John Shea talked to Derrick Jackson (Sheriff's Office is having one in Augusta) Would be 4 CJCC Forums throughout the year. Committee to work on forums: Matt Harshberger, Brian Mackie, Barbara Bergman, Mike Moran, Mr. Powell. Sheriff thinks should reach out for representation: to business community, Western part of the county (maybe Jeff Williams the Manchester Supervisor). John thinks if no objection, the Sheriff or Dir. Jackson can go ahead. Sheriff thinks it is important to have broad representation in the process. John thinks first thing is to decide where, bring the areas in to the process.

b. Implementation

Mr. Powell brought up the issue of the numbers on the Public Forum Committee, wanted to make sure was inclusive. Suggested might want have to a Commissioner. John said the purpose is to educate the community, have the public understand what

law enforcement does, align perceptions with reality. (Perceptions are in the Eastern part of the county that home invasions are up—when data shows they are down—perceptions could be result of better communication & annarbor.com. Mr. Powell thinks is great idea like the ENPACT meeting he holds. Sheriff: the small committee works on implementation—but will be opportunity to bring more people/different people as we implement. The planning committee would not necessarily be the presenters.

#### **4. JAIL UTILIZATION REPORTS**

Judge Shelton very interested in the New Jail Management Plan (how to handle overcrowding). We should have a July meeting. Sheriff: may be too much to discuss the campus plan at this meeting—John agrees that should be put off—probably to September.

#### **6. NEW BUSINESS**

Court is almost done --looks great (Gene DeRossett) Sheriff: project is almost done but have challenges. Biggest one is a major flood in the lower level where EOC, Evidence Room, Ammunition were. If the tornado had come through we would not have been able to activate the EOC. No back-up plan was in place. Clark should have had contingency plan in place. (Grates to sewer system were blocked to keep sediment out during construction.) Facilities has been very helpful. We have had a meeting around a long term strategy—possibly moving critical operations out of that area—may be structural issues. Sheriff: other major challenge is staffing/hiring. We have academy needing filling on June 21<sup>st</sup>. Backgrounds on applicants have been a challenge. Verna: BOC approved the amounts to complete the jail project (including resurfacing and creating a split drive off of Washtenaw, and demolishing the old court) Verna thinks will become part parking and part green area. Commissioner Bergman is concerned that there be sufficient parking. Verna will be monitoring. Mr. Powell thinks we will need all the parking we can get out there. When Verna gets the plans she will report back. Greg Dill: we will be opening the Court with the current parking (during demolishing of old Court and House by the Side of the Road.
