GENERAL INFORMATION: All decisions of the Judges and Horse Board are FINAL

Classes will be combined, canceled or divided at the discretion of the Horse Board.

The exhibitor's age is determined as of January 1, of the year they are exhibiting.

Checks returned for insufficient funds will be assessed an additional \$25.00 fee.

4-H Bulletin 1145 will govern all classes pertaining to equipment, tack, rules, etc. Chaps are optional in all Stock Seat classes.

Exhibitors will wear proper dress and horses will be in proper tack for all classes entered. Exhibitors will use the two-handed method of showing in all Fitting and Showing classes. **Entries** will close when the preceding class enters the ring. **No refunds will be given.**
Ponies - Height - 56" and under.

Hunter Hack class - Horses and/or ponies will be shown at the walk, trot, canter, and hand gallop both ways of the ring and will be required to jump two (2) obstacles that will be set in the middle of the ring. Schooling jump decided by Horse Board.

SEI Approved headgear is required in all Hunter on the flat, all over the fences classes, in all gymkhana (games) classes, and during practice/warm-up for these classes.

All exhibitors under the age of 10 must wear a ASTM/SEI helmet at all times while riding. This includes western riders as well.

Dressage classes will run in Ring #2 beginning at 10:00 a.m. Only two dressage classes per horse -rider combination may be ridden.

Trail classes will begin running at 10:00 a.m. Check at Announcer's Stand for location.

Horses may ONLY be tied at horse trailers. They may NOT be tied in the wash rack areas.

Before you leave the grounds, we ask that you clean the area around your trailer .

There will be a food stand on the grounds.

Clean up for ALL Washtenaw County 4-H Horse Clubs is scheduled for Monday after Spring Roundup at 6.30 p.m.

High Point intention by Age and/or Gymkhana MUST be indicated at the time of registration. A \$2.00 fee is required for each division signed up for High Point, i.e. - Gymkhana, Horse, Pony, or Walk/Trot.

All possible classes count towards High Point. Points are assigned as follows, regardless of number of entries; 6 points for 1st, 5 points for 2nd, 4 points for 3rd, 3 points for 4th, 2 points for 5th, and 1 point for 6th. Counting the number of 1st placings, etc will break high point ties.

The following classes count towards High Point awards:

16 - 18 Horse: 1, 7, 13, 14, 19, 24, 29, "32", 33, 38, 43, 48, 70 + 2 Dressage Test

13 - 15 Horse: 2, 7, 13, 14, 20, 25, 30, "32", 35, 39, 44, 48, 71 + 2 Dressage Test

10 - 12 Horse: 3, 7, 13, 14, 21, 26, 31, "32", 35, 40, 45, 49, 72 + 2 Dressage Tests

13 - 18 Pony: 1 or 2, 7, 13, 14, 22, 27, 29 or 30, 36, 41, 46, 48, 70 or 71 + 2 Dressage Tests

10 - 12 Pony: 3, 7, 13, 14, 23, 28, 31, "32", 37, 42, 47, 49, 72 + 2 Dressage Tests

13 - 18 Walk/Trot: 1 or 2, 8, 16, 73

9 - 12 Walk/Trot: 3, 9, 17, 74

16 - 18 Gymkhana: 52, 55, 58, 61

13 - 15 Gymkhana: 53, 56, 59, 62

10 - 12 Gymkhana: 54, 57, 60, 63
