



2008 4-H Junior Master Gardener Program

The 4-H Junior Master Gardener program has been offered in Washtenaw County since 1995. This year's program is open to any youth, 9 -11 years old (as of January 1 of the program year), who lives in Washtenaw County. The maximum class size is 15 students. Classes are completely project based, providing a high quality, positive learning experience on gardening and volunteering. Through this hands-on format, we hope to help kids discover that gardening is a fun activity, and volunteering is an important part of being a good citizen of the community.

To receive a certificate of recognition, each Junior Master Gardener program participant must attend all six classes, complete all quizzes and accumulate 10 volunteer hours. Participants can accumulate volunteer hours working in the JMG garden over the summer (they will plant this garden during class), or they may participate in activities coordinated or identified by the Washtenaw County MSUE office. They also may create their own volunteer activities (make sure these activities are cleared by the JMG Coordinator to qualify as JMG volunteer hours). Participants who complete the JMG certification requirements above will be recognized and will receive 4-H Junior Master Gardener certificate of accomplishment, during the annual 4-H Recognition Program.

Classes cover the following topics in an interactive, fun, and hands-on way: soil; plant science; vegetables; yard and garden pests; flowers; and woody plants and lawns.

Cost: A \$40.00 fee per student covers the cost of the 4-H Junior Master Gardener Reference book and classroom supplies.

Dates: Classes will be held on Tuesdays from 6:30 to 8:30 p.m., **May 6 through June 10**. There will also be a Salad Party June 17 and a Harvest Party September 17, and summer work session opportunities. Volunteer service hours are scheduled as opportunities arise.

Location: All classes will be held at Matthaei Botanical Gardens on Dixboro Road in Ann Arbor.
