

ACTION REQUESTED: Approval of providers to supported employment panel.

BACKGROUND:

Request for Proposals #6043, Supported Employment, solicited responses from 6 different bidders by the initial due date. This is an open panel bid, so bids may continue to be received until further notice by the WCHO.

Bidding was done in conjunction with all the counties in the regional affiliation. The review panel was comprised of administrative and clinical reviewers from all four counties. All RFP's were scored and reviewed according to the same criteria as listed in the RFP. A summary of the scores of each bidder is included.
