Participant hereby releases and discharges Washtenaw County from all claims, demands, actions or causes of actions to any such injuries or damages.

Important Information for Annual Pass Applicants

Passes are not transferable and there are NO REFUNDS!

*Passes may be **renewed** at the lower rate, provided that the pass is renewed **on or before** the expiration date.

** The family pass fee is based on a maximum of 4 members, living in the same house, with only 2 over 18 years of age. Additional minors who are immediate family members and are living in the same house may be added to the family pass for the applicable additional child fee.

The Recreation Center will continue to permit daily drop-in and annual pass use, in addition to offering recreation programs. Daily pass patrons and annual pass holders have equal use of the building, its equipment, and programs.

Participation in classes requires additional fees.

No minor under the age of 13 may enter the facility without their parent or guardian. Parents or guardians are responsible for the conduct and safety of their children at all times.

You must be 16 years of age or older to enter the cardio and strength training areas.

If your annual pass is lost or misplaced, you may enter the facility by using your picture identification for a period not to exceed seven (7) consecutive days. If you have not found your pass within this time frame, you must purchase a replacement card for \$1.00. If you choose not to replace the card, you are expected to pay the daily fee when you visit.

The annual pass ID is the property of WCPARC and must be surrendered upon expiration.

Parking in the MLM parking lot is limited - especially during the winter months. Overflow parking is available in the County Farm Park lot just south of the building, off of Platt Rd. Any cars not parked in a marked spot may be ticketed and/or towed at the vehicle owner's expense.

The track, pool and locker rooms are closed for cleaning at specific times each week. Please check the bulletin boards and schedules for those cleaning times.

The Recreation Center is closed on some County holidays, the two weeks prior to Labor Day, and any other time an emergency so dictates.
