1. MDEQ updates on PALL Project (Sybil Kolon)

- a. *Latest PLS/DEQ. database forwarded to interested parties(November 2006 version)*
 - i. A few data items remain missing but PLS intends to update
- b. *DEQ responded to PLS Maple Road Performance Plan comments from DEQ*
 - i. PLS has mixed response to “out-of-use” wells regarding abandonment
 1. Agreed to abandon some and not others, all the numbers remain few.
 2. Several other issues with identifying older out of use wells (1925 connections – old data).
- c. *DEQ Preparing a response to PLS comments on the DEQ review of the PLS Maple Road Performance Plan*
 - i. PLS responded on 12/21/2006 and is available online from the DEQ.
