The steel shingle roof would probably be our first choice because of the durability. When installed, it looks very similar to the current (cement) asbestos shingles. (see photos of home on Huron River Drive). These shingles would protect Gordon Hall for the next 50+ years. Best Roof of Chelsea would be contractor.

The rubber reinforced shingle also looks just like the asphalt shingles currently on the north and south porches. It also would last much longer than the asphalt shingles on the market today. Mr. Roof has promised a lifetime warranty on their shingle.

It should be noted, no part of the current roof is original.
