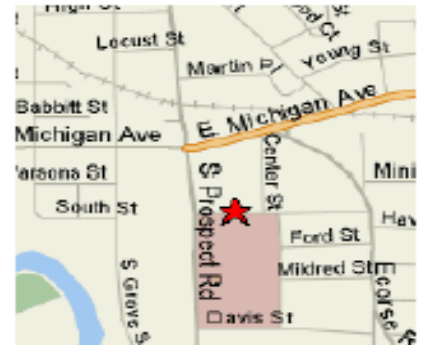

6. Park in the Center Street Parking Lot



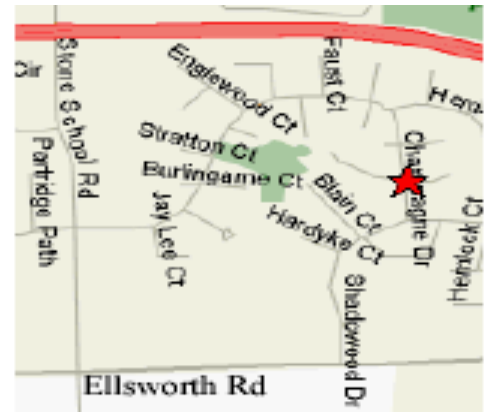
